**Subject: Short Closure of EPC Project in Ivory Coast**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Ashoka Buildcon Limited (“the Company”) informs that the Company had been subcontracted / awarded a Project viz. Construction of 100 drinking water wells and supply and installation of drinking water supply unit in 35 villages of Ivory Coast (“**Project**”) by M/s Serneke International Limited, Sweden on EPC basis, at Bid Price of Euros 18.50 Million.

Further to apprise that the Company and M/s Serneke International Limited have mutually decided to foreclose the said Project, after considering the terms & conditions of the Contract and progress of the Project. The parties have executed final closure of the Contract agreement on September 19, 2025 and settled the short closure of the contract with no further obligations on either parties. There is no negative financial impact on the Company.

The details of aforesaid project as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with the SEBI Circular Nos.
